5. Director Finance/FA/CAO/AO shall vouchsafe the utilization of funds as

per codal procedure/guidelines by GOI.

6. Other instructions conveyed vide Government Order No. 61-ST of 2015 dated 11-12-2015 may also be followed in letter and spirit before incurring expenditure.
