The Advance Drawl is subjected to the following conditions:

- The execution/implementation of works/schemes is carried out after observing all codal formalities including Administrative Approval & technical sanction and as per BADP guidelines and directions issued by PD&MD/Finance Department from time to time;
- Proper and transparent e-tendering process is adopted in the execution of works and purchase of material/equipments;

projects funded through JKIDFC and no part or a whole of any work already executed under any of other programme is debited to BADP funds released;
