The Advance Drawl is subjected to the following condition:

- i. Accounts Officer of the Council shall vouch safe the availability and proper utilization of funds.
- ii. Accounts Officer shall submit the Red Account of the amount to Accountant General Office with intimation to this Department.
- iii. Funds shall be utilised for the specific purpose for which these have been released after fulfilling all codal /Procedural formalities and as per the instruction/guidelines issued by Science and Technology Department and as well as by the Finance and Planning Departments from time to time.
- iv. No re-appropriation of funds at any stage shall be permitted.
- v. The funds shall neither be parked nor diverted in any case.
- vi. The funds for the purpose are available under the relevant head of account.
- vii. Due e-tendering procedure shall be followed in letter and spirit and AA/TS shall be in place before booking any expenditure.


