- 5. That, there is no time or cost overrun involved in the project and set time line shall be strictly adhered to. No escalation shall be admissible under any circumstances.

- 6. That, the Executing Agency shall be selected as per the terms & Conditions of the NIT, by the designated Competent Authority to finalize the vendor.
- 7. Photographic evidence before, during and after completion of project shall also be submitted for record and reference purposes alongwith geocoordinates.
- 8. That, the CEO, JAKEDA shall apprise the Administrative Department on monthly basis about the progress of the works, once started by the **Executing Agencies.**
- 9. That the Administrative Approval should neither be construed as any rate approval nor Technical sanction of the Project.
