

Subject: Accord of Administrative Approval for installation of 5000 numbers of Solar Pumps.

Reference:- Administrative Council decision No.88/14/2021 dated 7.10.2021,

Government Order No: 32-JK(ST) of 2021 Dated: 01.11-2021

Pursuant to the Administrative Council decision No.88/14/2021 dated 7.10.2021, Administrative Approval is hereby accorded for the installation of 5000 nos of Solar Pumps having a capacity range from 1 HP to 10 HP under Prime Minister's Kissan Urja Suraksha Evam Uthaan Mahaabhiyan (PM-KUSUM) Scheme at an estimated project cost of Rs 135 crore envisaging UT share of Rs 45.72 crores. The project is to be implemented during the financial years 2021-22 & 2022-23, as per the MNRE approved timelines.

The Administrative Approval is subject to the fulfillment of following conditions:

- 1. That, the supplies to be received shall be verified and shall be strictly as per the latest specifications as approved by the MNRE/ specifications of the NIT floated by EESL and the material shall be got verified in terms of MNRE guidelines.
- 2. That, the rates as approved by the MNRE/EESL shall be strictly adhered to.
- 3. That, there is no time or cost overrun involved in the project and set time line shall be strictly adhered to. No escalation shall be admissible under any circumstances.
- 4. That, the Executing Agency shall be selected as per the MNRE directions after following due procedures/Codal formalities.
- 5. Photographic evidence before, during and after completion of project shall also be submitted for record and reference purposes alongwith geocoordinates.

- 6. That, the CEO, JAKEDA shall apprise the Administrative Department on monthly basis about the progress of the works, once started by the Executing Agencies.
- 7. That the Administrative Approval should neither be construed as any rate approval nor Technical sanction of the Project.
